Cameron Park Youth Ignite Week – Youth Art Competition

Competition Period	Submissions accepted from Monday, May 19, 2025, to Monday, June 30, 2025
Prize Announcement	1 st Week of July 2025

1. Eligibility

- The competition is open to two age categories:
 - Youth Category: Teenagers aged 13 to 18 years at the time of submission.
 - Kids Category: Children aged 5 to 12 years at the time of submission.
- Participants must be residents of Australia.
- Employees, immediate family members of employees of Cameron Park Plaza are not eligible to participate.
- No purchase is necessary to enter.
- All participants under 18 must have parental or guardian consent to enter. For the Kids Category (ages 5–12), a parent or guardian must submit the entry on behalf of the child and provide consent via the submission form (online or in-person).

2. Submission Guidelines

- **Theme:** Entries must reflect the theme “What’s Your Vibe?” and express the participant’s personality, dreams, or vision of the future.
- **Accepted Formats:** Painting, drawing, digital art, photography, or mixed media.
- **Submission Methods:**
 - **In-Person:** Physical artworks must be dropped off at the designated booth at Cameron Park Plaza (CMO) during operating hours from May 19 to June 30, 2025.
 - **Online:** Digital submissions must be uploaded via the Youth Ignite Week microsite by 11:59 PM AEST on June 30, 2025.
- **Size and Format Requirements:**
 - Physical artworks must not exceed **A2 size (420mm x 594mm)** and must be unframed.

- Digital submissions must be in **JPEG or PNG format**, with a minimum resolution of **1920x1080 pixels** and a file size not exceeding **10MB**.
- Each participant may submit **one (1) entry** only.
- Entries must be original works created by the participant (or with minimal adult assistance for the Kids Category) and must not infringe on any copyright, trademark, or other intellectual property rights.
- Entries must not contain offensive, defamatory, or inappropriate content, as determined by the organisers.

This includes, but is not limited to:

- Content that promotes violence, hatred, or harm toward individuals or groups.
- Material that is sexually explicit, obscene, or pornographic.
- Depictions or references to illegal activities, including drug use or vandalism.
- Content that discriminates based on race, ethnicity, gender, religion, sexual orientation, disability, or any other protected characteristic.
- Defamatory statements or imagery that could harm the reputation of individuals, organizations, or Cameron Park Plaza.
- Political or religious messaging that could be deemed divisive or inflammatory.
- Any content that violates Australian laws or regulations, including copyright or intellectual property laws.
- Imagery or text that may cause distress or discomfort to a general audience, particularly in a family-friendly community setting.

The organisers reserve the right to disqualify any entry deemed to violate these standards at their sole discretion.

- Physical artworks must include the participant's name, age, category (Youth or Kids), and parent/guardian contact details (phone number and email) on the back of the artwork.
- Digital submissions must include the same details in the online form on the microsite, with a parent/guardian completing the form for Kids Category participants.

3. Submission Period

- Submissions open on **Monday, May 19, 2025, at 9:00 AM AEST** and close on **Monday, June 30, 2025, at 11:59 PM AEST**.
- Late submissions will not be accepted.
- Physical artworks will not be returned unless requested by the participant (or parent/guardian for Kids Category) at the time of drop-off. Unclaimed artworks will be disposed of after **July 31, 2025**.

4. Prizes

Youth Category (ages 13–18):

- **Grand Prize (1 winner):**
 - \$500 gift card
 - Art supply kit (valued at approximately \$50).
 - Artwork displayed in Cameron Park Plaza for the month of July
- **Runner-Up Prizes (2 winners):**
 - \$200 gift card
 - Art supply kit (valued at approximately \$50).
 - Artwork displayed in Cameron Park Plaza for the month of July.

Kids Category (ages 5–12):

- **Grand Prize (1 winner):**
 - \$100 gift card
 - Art supply kit (valued at approximately \$50).
 - Artwork displayed in Cameron Park Plaza for one month (June 9 – July 9, 2025).
- **Runner-Up Prizes (2 winners):**
 - \$50 gift card
 - Art supply kit (valued at approximately \$25).
 - Artwork displayed in Cameron Park Plaza for one month (June 9 – July 9, 2025).

Prizes are non-transferable and cannot be exchanged for cash or other alternatives. Gift cards are subject to the terms and conditions of the issuing stores.

5. Judging

- Entries will be judged separately for each category (Youth and Kids) by a panel selected by Cameron Park Plaza based on:
 - Creativity and originality (40%).
 - Alignment with the “What’s Your Vibe?” theme (30%).
 - Technical skill and presentation (30%), adjusted for age-appropriate expectations in the Kids Category
- The judges’ decision is final, and no correspondence will be entered into.
- Winners will be notified by phone and/or email (via parent/guardian for Kids Category) on or before **July 10, 2025**.

6. Intellectual Property and Publicity

- By submitting an entry, participants (or their parent/guardian for Kids Category) grant Cameron Park Plaza a non-exclusive, royalty-free license to display, reproduce, and publish their artwork for promotional purposes related to the competition, including but not limited to in-centre displays, social media, and the Youth Ignite Week microsite.
- Participants retain ownership of their artwork's copyright.
- Winners agree to have their names, ages, and artworks featured in promotional materials, unless prohibited by law.
- Participants submitting physical artworks acknowledge that Cameron Park Plaza is not responsible for any loss, damage, or theft of artworks during the competition or display period.

7. Privacy

- Personal information (name, age, phone number, email) collected during the competition will be used solely for the purpose of administering the competition and contacting winners.
- For the Kids Category, all personal information must be provided by a parent or guardian.
- Cameron Park Plaza will handle personal information in accordance with its Privacy Policy
- Participants under 18 must obtain parental/guardian consent to provide personal information and participate, with explicit consent required for the Kids Category via the submission form.

8. General Conditions

- Cameron Park Plaza reserves the right to disqualify any entry that does not comply with these Terms and Conditions or is deemed inappropriate.
- The organizer may cancel, modify, or suspend the competition due to unforeseen circumstances (e.g., technical issues, insufficient entries, or force majeure). Participants will be notified via the microsite or in-centre announcements.
- Cameron Park Plaza is not liable for any costs, damages, or losses incurred by participants in connection with the competition, except as required by law.
- By entering, participants (or their parent/guardian for Kids Category) agree to be bound by these Terms and Conditions.
